

ENVIRONMENTAL TECHNICIAN

Reporting to: Technical report to ESG Manager with functional report to Exploration Manager during baseline studies

Place of work: Vares; Veovača and Rupice concessions and related study areas

The candidate will be required to carry out the following duties:

1.With the input of various technical experts from Wardell Armstong and local groups, carry out baseline environmental monitoring throughout the concession. This will include, but is not limited to:

- Surface water flows
- Surface water quality
- Ground water levels
- Ground water quality
- Meteorology including snow depths
- Air quality (dust deposition)
- Noise
- Biodiversity (Camera traps)

2. Set up, maintain and carry out basic repairs to the equipment required for the above monitoring; calibrate or arrange calibration where necessary, store equipment safely and ensure that spare parts are readily available.

3. Operate the equipment as required to fulfil the monitoring programme on a regular periodic basis (e.g. weekly, monthly, quarterly), including data downloads.

4. Collect, label and store samples for shipment to laboratories in accordance with the required sampling protocols and QA/QC procedures; ensure spare sampling equipment is available. These samples are likely to include surface water and ground water.

5. With the input of the Wardell Armstrong team if required, set up a database to record monitoring results and maintain this on a regular basis. Carry out basic analysis of data, e.g. flagging exceedances of nominated environmental standards.

6. Working with Wardell Armstrong and other consultants, support all technical baseline study teams as required, with particular reference to ground conditions, access, logistics (e.g. transport, subsistence, accommodation, equipment, field assistants), health and safety and emergency procedures. These studies are likely to include soils and sediments, archaeology, air quality, noise, biodiversity, ecosystem services, landscape and socio-economic studies.

7. Set up a simple system for recording wildlife sightings around the concession areas and maintain this in a log book.

8. Provide assistance and support to the Information Centre staff with ongoing community liaison activities and in operating the grievance mechanism that will be set up. The Information Centre will ensure that the Technician is provided with the latest information that is being shared about the project, including when Project activities are being carried out, which might lead to community concerns.

9. Provide data to the ESG Manager and nominated members of the Eastern Mining team as required, including a written monthly report summarising activities, results and activities planned for the following month.
